Dear Ms. Small:

Bisbee Unified School District does not enroll students who are not residents of the United States.

For students who reside in the State of Arizona but do not reside in the District and who are enrolled pursuant to open enrollment, we receive state aid. For 2007, the amount of such aid was \$9,251 for each special education student and \$6,644 for other students. In 2008, the amount of such aid was \$9,414 for special education students and \$7,044 for others.

We enroll students from three Arizona K-8 school districts that do not have a high school: Naco, Double Adobe and Palominas. They pay us tuition for each of their students as set forth in A.R.S. §15-824E. For each of these we received the following tuition: 2007 Special Education \$9,414, all other students \$6,644; and in 2008 Special Education \$9,414, all other students \$7,044.

The District provides the same educational services to non-District residents as it does for resident students. Regarding 504 or Special Educations students, services that are provided are contained in the individual student files and are not public record.

If there are specific documents that you need related to this matter, please let me know, but I believe the above information has addressed the questions raised in your records request.
