<p>TERMINAL EVENT:</p> <p>On Wednesday, January 6, 2021, members of Homicide Squad [REDACTED] were summoned to 110 Irving Street NW, Washington, DC (Medstar) for the report of an apparent shooting. It was reported to detectives the victim was shot inside of the US Capitol building. After being shot the victim was transported to Medstar for advance life support, however, after several attempts to revive the victim, she succumb to her injury and was pronounced dead at 1515 hours by Dr. [REDACTED] the attending physician.</p> <p>INVESTIGATION/MEDICAL HISTORY:</p> <p>Detectives learned the decedent was involved in a first amendment demonstration at the US Capitol. Detectives also learned though the course of this investigation that the decedent was shot by a member of Law Enforcement after forcibly breaching a secured room at First Street, Southeast, Washington, DC, (US Capitol Building).</p>
