LEO(S): (b) (6), (b) (7)(C)

At 0323, 05MAY24, LEO (b) (6), (b) (7)(C) observed a white 2011 Freightliner box truck bearing Virginia registration (b) (6) traveling east on Fuller Road adjacent BLDG 3060 (Gate 1), MCB Quantico, VA 22134 towards a 100% identification checkpoint. The vehicle was stopped, and contact was made with the operator, identified as (b) (6) who stated he was making a delivery to the post office located in the town of Quantico. (b) (6), (b) (7)(C) asked (b) (6) if he had base access, to which (b) (6) stated that he did not, and was asked to provide an itinerary for the delivery and identification for himself and his passenger, identified as (b) (6).

(b) (6), (b) (7)(C) received a Virginia operator's license for (b) (6) and a Jordan Passport for (b) (6) at which time he instructed (b) (6) to move the truck to the holding area and wait for a vehicle inspection and visitor check. As the vehicle was approaching the holding area, (b) (6), (b) (7)(C) noticed the vehicle was not stopping and was proceeding onto MCB Quantico Property. The final denial barriers were activated by LEO (b) (6), (b) (7)(C) and the vehicle stopped prior to the barrier.

LEO (b) (6), (b) (7)(C) made contact with (b) (6) and had the vehicle moved into the holding area and out of the flow of traffic at which time LEO(s) (b) (6), (b) (7)(C) arrived on scene to assist and the final denial barriers were reset.

At 0413, 05MAY24, (b) (6), (b) (7)(C) placed (b) (6) in hand irons for trespassing and transport back to PMO where he was processed accordingly.
