GENTEXT/REMARKS/THIS REPORT PROVIDES DETAILS OF UNAUTHORIZED ACCESS THAT OCCURRED ON MARINE CORPS BASE QUANTICO AT FULLER GATE (FULLER ROAD GATE, BLDG 3060).

2. DATE / TIME OF INCIDENT: 03MAY2024/0323
3. INDIVIDUAL/VEHICLE LOCATED: YES. INDIVIDUAL LOCATED AT 0323, STOPPED BEFORE FINAL DENIAL BARRIERS.
4. GATE NUMBER/NAME AND EXIT OR ENTRY LANE: FULLER GATE (FULLER ROAD, BLDG 3060), LANE 1.
5. FINAL DENIAL BARRIER ACTIVATED: YES.
6. INCIDENT DESCRIPTION:
 - 6.A. AT APPROXIMATELY 0320, 03MAY2024, PMO OBSERVED A WHITE BOX TRUCK ATTEMPTING TO ACCESS THE INSTALLATION VIA THE FULLER ROAD GATE. PMO SENTRY MADE CONTACT WITH THE OPERATOR IDENTIFIED AS MOHAMMED KHAIR HASSAN DABOUS WHO STATED HE AND HIS PASSENGER, IDENTIFIED AS HASAN YOUSEF HAMDAN WERE ATTEMPTING TO MAKE A CARGO DELIVERY TO THE U.S. POST OFFICE LOCATED AT 400 5TH AVENUE, QUANTICO, VIRGINIA. SENTRY REQUESTED DABOUS' LICENSE TO CONDUCT A VISITOR CHECK AND DIRECTED DABOUS TO MOVE THE BOX TRUCK INTO THE INSPECTION AREA TO AWAIT FURTHER INSTRUCTIONS.
 - 6.B. WHILE TRANSMITTING THE DRIVER'S LICENSE INFORMATION FOR VETTING, (b) (6), (b) (7)(C) OBSERVED THE BOX TRUCK MOVING FORWARD FROM THE HOLDING AREA. (b) (6), (b) (7)(C) DEPLOYED THE FINAL DENIAL BARRIERS. INBOUND

TRAFFIC WAS SUSPENDED WHILE (b) (6), (b) (7)(C) RAN TOWARDS THE BOX TRUCK THAT HAD STOPPED PRIOR TO THE DEPLOYED BARRIERS. NO VEHICLES MADE CONTACT WITH THE BARRIERS AND NO INJURIES WERE REPORTED.

6.C. AT 0325, (b) (6), (b) (7)(C) TACTICALLY APPROACHED THE VEHICLE AND MADE CONTACT WITH THE DRIVER, DABOUS, AND INSTRUCTED HIM TO RETURN THE VEHICLE TO THE HOLDING AREA. A DRIVER QUERY WAS COMMUNICATED TO DISPATCH, WHICH RETURNED WITH NO DEROGATORY INFORMATION FROM (b) (7)(E) (b) (7)(E) FURTHER INVESTIGATION REVEALED THE PASSENGER, HAMDAN COULD ONLY PROVIDE A JORDANIAN PASSPORT FOR IDENTIFICATION. SUBSEQUENT VETTING RETURNED NO DEROGATORY INFORMATION FOR HAMDAN FROM (b) (7)(E) (b) (7)(E) A SEARCH OF THE VEHICLE REVEALED MULTIPLE AMAZON PACKAGES.

6.D. AT 0413, DABOUS AND HAMDAN WERE TAKEN INTO CUSTODY AND SEPARATELY TRANSPORTED TO PMO FOR FURTHER INVESTIGATION.

6.E. INVESTIGATION REVEALED DABOUS IS EMPLOYED BY (b) (6) A SUBCONTRACTOR THAT OVERSEES LOGISTICS FOR AMAZON DELIVERIES. FURTHER INVESTIGATION REVEALED THAT HAMDAN IS A FRIEND OF DABOUS AND NOT AN EMPLOYEE OF THE DELIVERY COMPANY. ADDITIONALLY, HAMDAN ILLEGALLY ENTERED THE UNITED STATES 20 DAYS AGO FROM MEXICO INTO CALIFORNIA, WHERE HAMDAN WAS ARRESTED AND SENT TO AN IMMIGRATION CAMP WITH A DEPORTATION COURT DATE IN 2026.

6.F. ADDITIONAL VETTING OF DABOUS AND HAMDAN THROUGH (b) (7)(E) RETURNED NO DEROGATORY INFORMATION; HOWEVER, THE (b) (7)(E) GENERATED (b) (7)(E) (b) (7)(E) NOTIFICATION THAT RESULTED IN ICE OFFICER (b) (6), (b) (7)(C) TELEPHONICALLY CONFIRMING TO CID THAT HAMDAN WAS ON A TERROR WATCH LIST.

6.G. AT 0958, ICE PERSONNEL ASSUMED CUSTODY OF HAMDAN AND DABOUS FOR FURTHER PROCESSING. THE DELIVERY TRUCK IS PENDING RELEASE TO THE COMPANY OWNER.
