As we noted in our letter dated June 20, 2024, we are processing your request for material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. The Department of State ("Department") has identified an additional 16 responsive records subject to the FOIA. Upon review, we have determined all 16 records may be released in part.

Dispatch from Munich: The lessons of appeasement for US lawmakers withholding support for Ukraine

MUNICH—The stench of appeasement hung over the Munich Security Conference this past weekend, leaving more than a few European leaders making comparisons to September 1938. That was when a very different Munich meeting placated a murderous dictator—with disastrous consequences.

It was then that British Prime Minister Neville Chamberlain, meeting with Nazi leader Adolf Hitler and their French Republican and Italian fascist counterparts, signed off on the Third Reich's annexation of the Western part of Czechoslovakia (which the Germans called Sudetenland), naively hoping that would allow them to avoid a larger European war.

With the two-year mark of Russian dictator Vladimir Putin's full-scale invasion of Ukraine coming up this week—and with his ongoing war and occupation of

sovereign Ukrainian territory—it's worth reflecting on the dynamics behind the 1938 Munich Agreement and Chamberlain's subsequent "Peace for Our Time" speech, as they may hold lessons for US lawmakers in the House of Representatives who continue to balk at approving urgently needed support for Ukraine after four months of dithering in Congress.

Hitler had threatened to unleash a European war unless the leaders of Britain, France, and Italy agreed to German annexation of the Sudetenland, a border region with an ethnic German majority. "My good friends," Chamberlain said in a statement in front of 10 Downing Street, "for the second time in our history, a British prime minister has returned from Germany bringing peace with honor. I believe it is a peace for our time . . . Go home and get a nice quiet sleep."

Echoes of history

There are plenty of differences between then and now, but one shouldn't overlook the striking similarities.

First, Hitler had annexed German-speaking Austria in March 1938, and he was determined to swallow up the German-speaking Sudeten region of Czechoslovakia next. Today, Putin has already occupied and annexed portions of Ukraine with sizable numbers of Russian speakers—areas that he considers to be his property: Crimea, Luhansk, Zaporizhzhia, Kherson, and Donetsk.

Hitler wrote at length about his warped historic, genetic, and anti-Semitic notions in *Mein Kampf*, providing a copy of his national best-seller to every young marrying couple in Third Reich Germany. By comparison, Putin most recently shared his own twisted justifications for denying Ukrainian statehood, dating back to the ninth century, with American media personality Tucker Carlson—not such a bizarre vehicle if one considers Carlson's influence on a Republican minority in the House that is currently standing in the way of approving additional aid for Ukraine.

And just as in 1938, when the focus of debate was on the future of Czechoslovakia and when commentaries praised the country's bravery and resilience, so too now is the focus on Ukraine. Back then, the more appropriate focus should have been on the dictator responsible for the threat and on how to stop him. Today, the more appropriate focus is no different.

One more similarity between 1938 and today is the gradual alignment of authoritarian powers. Shortly after Chamberlain's infamous Munich Agreement, a fascist-nationalist German-Italian-Japanese axis of nations emerged. Today, European and US leaders alike have observed an increasingly close alignment among Russian, Chinese, Iranian, and North Korean authoritarian leaders.

A morose Munich

The Munich Security Conference this week, which marked the convening's sixtleth anniversary, is as good a measure of the transatlantic zeitgeist as any.

Yet four news events that unfolded outside of Munich soured the mood: Former US President Donald Trump's campaign trail statement that he would let Russians "do whatever the hell they want" to NATO allies not paying enough for defense; the death in prison of Russian opposition leader Alexei Navalny; the biggest Russian battlefield victory in months in the Ukrainian city of Avdiivka; and leaked reports of Moscow's plans to develop a nuclear space weapon, which the Atlantic Council's John Cookson suggested could be a "Sputnuke" moment.

On Trump's statement, a range of Republican supporters of Trump in Munich were at pains to explain why their presidential candidate should be taken seriously but not literally, as US military support for Ukraine, Poland, and NATO increased during his administration. Their argument that Trump simply wants Europeans to carry more of their own defense still left allies worried that they are in for a long period of US unpredictability.

Regarding Navalny, his wife Yulia (who was in Munich to speak on his behalf) provided a courageous first response to reports of his death, accusing Putin of killing him and vowing that the Russian dictator would pay for it. Some long-time Munich conference participants, who heard Putin's initial declaration of war on the West there in 2007, speculated that he might well have timed Navalny's death with

the Munich gathering to send an unmistakable message of the West's

"It sounds like Putin might have done it for our benefit," said Polish Foreign Minister Radek Sikorski. "I'm not prone to conspiracy theory, but I understand conspiracy

It is impossible not to link Russian advances in Ukraine with the long delay in US congressional support for new weapons deliveries, as the outgunned and outmanned Ukrainians struggle to hold the line against Russian forces commanded by Putin, who is willing to suffer outsized casualties. Ukrainian President Volodymyr Zelenskyy said that in the battle for Avdiivka, Russia's losses were seven times those of Ukraine.

If "Ukraine is left alone, Russia will destroy us," Zelenskyy told the Munich conference. "If we don't act now, Putin will succeed in turning the next few years into a catastrophe —not only for Ukraine but for others as well."

On "Sputnuke," the consensus in Munich was a resigned European shrug as Russia marches on, develops asymmetric advanced weaponry that could take down European communications in space, and shifts to a war footing that Europe's democracies will never match.

Writing for the Washington Post, David Ignatius pointed out Russia's motivation for developing such weaponry: "Ironically, it's the Ukraine conflict—and the role of

space systems in helping Kyiv survive the initial Russian onslaught in 2022—that likely triggered Russia to rush development of its new space tactics."

Four causes for concern

The concerns and fears at Munich this year, which far overwhelmed rare voices of optimism, broke down into four mutually reinforcing categories.

The first fear was about Russia's resilience and Putin's increasing confidence, which contributed to a growing conviction that Russia will remain a problem for the West for some years to come.

The second concern stemmed from the possibility that Ukraine might lose the war, with a growing danger that it could be overwhelmed by Russian military mass, and from an assessment of the repercussions of that scenario most immediately for other former Soviet bloc states, from Poland to the Baltics, but also globally, from the United States to the Middle East and Asia.

The third concern, one that pervaded almost every conversation at the conference this weekend, was about the potential for a reduced US commitment not only to Ukraine but also to the nearly eighty-year-old transatlantic bond, particularly should Trump be elected in November.

The fourth fear, closely connected to the third, was that Europe still lacks the military industrial capacity and the political will to defend itself, let alone defend Ukraine. Though Europe is ramping up its defense industrial production and increasing its spending, it would take years for European countries to replace US capacity, if they ever could.

The past three Munich Security Conferences have all focused on Ukraine, and each year the conventional wisdom has missed the mark. One can only hope that is true again.

In 2022, there were growing concerns that Putin would invade Ukraine, which did happen, but there was also a consensus that Ukraine would be overrun within days by such a military offensive. In 2023, the mood was more positive, with many voices believing that Ukraine's remarkable performance in the previous year could lead to a stunning counteroffensive that would help Kyiv regain territory occupied by Russia.

The collective view is that 2024 will be a moment of truth in Ukraine. Without US congressional approval for additional support soon, the thinking goes, the odds are that Russia will continue to make gains and that some could be dramatic by the time of the seventy-fifth NATO Summit in July in Washington, DC—just ahead of US elections.

It is worth remembering the calls of "shame" from the House of Commons galleries, as Chamberlain defended his Munich arrangements in 1938. "I have nothing to be ashamed of," he answered back. "Let those who have hang their heads."

Not too late—yet

It's worth reading what Chamberlain said after returning from Munich as a warning to all who are tempted to sell Ukraine short, underestimate Putin and other emerging despots, and retreat into the most dangerous of all responses: naive complacency.

"The path which leads to appearement is long and bristles with obstacles," said Chamberlain. "The question of Czechoslovakia is the latest and perhaps the most dangerous. Now that we have got past it, I feel it may be possible to make further progress along the road to sanity."

There is an oft-repeated quote that says "insanity is doing the same thing over and over again and expecting different results."

It's not too late for the US House of Representatives to change course, to bring a vote on a Senate bill providing Ukraine aid to the floor, and to provide Ukraine the support it urgently needs to do the free world's bidding against Putin. Should this fail, Europe would need to greatly accelerate its ramp-up of defense production and its support for Ukraine.

The lesson of Munich, then and now, is that the cost of countering a despot will only grow the longer democracies wait to do so. As Sikorski said in Munich, "I have more doubts about us than the Ukrainians." If the United States fails to step up to the moment this year, he said, "it could affect the national-security calculations of every country on Earth. We are at a dramatic moment, one of terrible foreboding."



Politico.eu (February 7) - Tucker Carlson is interviewing Russian President Vladimir Putin. The reaction has been apoplectic. Carlson, a conservative pundit and former Fox News anchor who has repeatedly questioned support for Ukraine's war effort, announced Tuesday night his plans to sit down with the Russian president during his trip to Moscow. In a video that racked up more than 60 million views by Wednesday morning, Carlson said he was interviewing Putin "because it's our job. We're in journalism. Our duty is to inform people." But Carlson's monologue, in which he lambasted Western media and claimed it wasn't making an effort to hear Putin's side of the story, has sparked backlash from American and Russian journalists. "Many journalists have interviewed Putin, who also makes frequent, widely covered speeches," wrote Anne Applebaum, an American journalist and historian, on X (formerly Twitter). (SBU) Still Uncertainty around Death and Body

2. (SBU) As of Tuesday afternoon – four days after Navalny's passing – there continued to be uncertainty regarding the cause of death and the location of his body. Soon after the prison's press release, state media reported that the cause of death had been a blood clot (otorvalsya tromb). Over the weekend, however,

Navalny allies reported that when Navalny's mother arrived at the morgue, she was told it was "sudden death syndrome." Navalny's mother and a lawyer were not permitted to see the body, and reportedly told it was not located in the Salekhard morgue (the city closest to the prison), and later told that authorities would need 14 days to run "chemical tests." Independent outlet *Mediazona* later published footage from a webcam purporting to show a police convoy heading away from the prison sometime around midnight the night before Navalny's mother visited the area. Many commentators concluded the body had been moved in advance of her visit. Separately, *Novaya Gazeta Europe* reported, based on anonymous sources, that Navalny's chest had unusual bruising, as though he had been held down prior to receiving chest compressions, while *Verstka* reported that there had been unusual lockdowns and searches at the prison the day before the death.

3. (SBU) Though Russian law requires releasing the body to the next of kin, a number of commentators said the government could seize on Navalny's "extremist" and "terrorist" designations to avoid handing it over. Even if there were no foul play, most commentators assumed the authorities would want time to think through how a public funeral and burial might affect protest mood in advance of the March 15-17 presidential election. As Berlin-based Carnegie expert Tatiana Stanovaya wrote online, given President Putin's fear of external interference, the regime likely views any unrest resulting from Navalny's death as an attempt by Navalny's supporters to damage the triumph of his re-election.

(SBU) In Moscow, Liberal Society in Muted Grief

4. (SBU) While there was a flood of grief online, Moscow's streets were relatively quiet, especially compared to protests at the beginning of the war or in previous Navalny-led actions. On Friday night, several hundred people gathered in what appeared to be an orderly and mostly quiet line to lay flowers at the Solovetsky Stone, a memorial to prisoners of the Gulag on Lubyanka Square, in front of FSB headquarters. Police presence was heavy. Mourners also brought flowers to the Wall of Shame, a memorial to political repression, as well as the memorial to Boris Nemtsov on a bridge adjacent to Red Square. Media reported that the hundreds of flowers, piled high at each location, were removed by plain-clothes security officers overnight. By Saturday morning, Lubyanka Square was quiet and mostly clear of people, except for a few cameramen and a number of conspicuous

security types taking pictures of anyone who approached the memorial. By midday, the number of visitors picked up again, as did the number of police. The Australian, Canadian, Danish, and UK ambassadors laid flowers at the site. OVD-Info, which tracks protest-related arrests across Russia, reported 396 people detained over the weekend in 39 cities. Media reports suggested police primarily detained those who unfurled banners or shouted slogans, while mostly leaving quiet mourners alone. Ambassador Tracy laid flowers at the site Sunday morning, the square mostly quiet and empty. (b)(6) reported the same later that afternoon, and speculated that the arrests from days prior might have dampened turnout.

(SBU)-Opposition's Next Steps Unclear

5. (SBU) Yuliya Navalnaya – Alexey's wife – briefly addressed the Munich Security Conference on Friday, soon after news broke of her husband's death. Visibly shaken, she said she held Putin personally responsible for Alexey's death – as well as "what they've done to the country" – and called for the defeat of "this horrific regime." Over the weekend, she released a video reminiscent of Alexey's, asserting that she knew who was responsible for the death and would reveal the details of an investigation soon. Separately, independent outlet *Kholod* published a list of names and pictures of all Russian officials who had been involved in

Navalny's various investigations and court proceedings under the headline "Evil has a name." But given the preexisting organizational tensions within Navalny's Anti-Corruption Foundation and the opposition movement more generally (B-C), it remained as unclear as ever how Russia's regime opponents and anti-war protestors might proceed in Navalny's absence.

(SBU)-Supporters: The Candle as the Last Available Protest

6. (SBU) Liberal commentators and Navalny supporters were uniform in their grief and generally saw Navalny's death as marking the end of hope for the opposition movement within the country. Carnegie expert Andrei Kolesnikov called the candles, carried by individuals to the memorial, "the last weapon of a civilized person and citizen," and labeled the authorities the "not the heirs of the Great Victory of 1945, [but] of the Great Terror of 1938." Yuri Dud, one of Russia's most popular YouTube journalists, who interviewed Navalny while he recovered in Germany from Novichok poisoning, wrote that, "Putin's Russia is built on fear" but Navalny had provided an example of "fearlessness," his "superpower" after deciding to return to the country in January 2021. Dud hoped that the "signal" of fearlessness would permeate society even after death. Popular liberal blogger Alexander Gorbunov (Stalin_Gulag) argued that Navalny's power stemmed from his hopeful recognition that he worked with and for the Russian people, and did not see them as "genetic slaves...who cannot live without a strong hand." Gorbunov opined that there were few liberal political actors willing to take the same approach.

8. (SBU) Though Putin has still not commented on the death, officials and propagandists wasted little time in fostering conspiracies. Duma Speaker Volodin issued a statement saying, "Washington and Brussels are to blame for Navalny's

death," because, "Who benefits from Navalny's death?...those who imposed more than 19,000 sanctions against Russia [and] are losing the war in Ukraine." The Ministry of Foreign Affairs wondered, on Telegram, why "for the White House and the State Department the death of a Russian citizen in a Russian penal colony turned out to be much more important and more terrible than the death of an American citizen, journalist Gonzalo Lira," in Ukraine.

(SBU) On his Sunday evening show, Kremlin mouthpiece Vladimir Solovyov and RT editor-in-chief Margarita Simonyan said it was curious that Navalny had died right as Western leaders gathered for the Munich Security Conference, as though they hoped his death would galvanize support against Russia and distract from Putin's recent interview with Tucker Carlson. "The timing raises big questions," said Simonyan, continuing, "it doesn't benefit Russia or the government, but for them the timing is excellent, with elections coming up." (Note: Navalny ally Ilya Yashin, writing from prison where he is serving his own eight-and-a-half year term for spreading "false information" about the war, called "complete nonsense" the idea, spread by state propaganda, that killing Navalny a month before the election would be "illogical." "In Putin's understanding, this is how power is asserted: through murder, cruelty, and demonstrative revenge," wrote Yashin. End note.) In a particularly odious turn, she then criticized Yuliya Navalnaya for making a number of statements at the Conference, "as though she didn't really love her husband, but power and press conferences."

10. (SBU) In a more restrained comment, the popular anonymous Telegram channel *Nezygar* — widely assumed to be written by someone within the Presidential Administration — wrote that the majority of Russians saw Navalny as someone who went against the system, which was both dangerous and futile. His death was, therefore, foreseeable, and would not have any effect on the system itself. The writer further speculated, as other pro-regime commentators have, that Navalny's death and Navalnaya's outspoken approach, could lead to calls in the West for a "government in exile." "This radical rhetoric, clearly agreed upon by curators from Western countries, should not be ignored," the channel's author wrote.

(SBU) Still Uncertainty around Death and Body

2. (SBU) As of Tuesday afternoon – four days after Navalny's passing – there continued to be uncertainty regarding the cause of death and the location of his body. Soon after the prison's press release, state media reported that the cause of death had been a blood clot (otorvalsya tromb). Over the weekend, however, Navalny allies reported that when Navalny's mother arrived at the morgue, she was told it was "sudden death syndrome." Navalny's mother and a lawyer were

not permitted to see the body, and reportedly told it was not located in the Salekhard morgue (the city closest to the prison), and later told that authorities would need 14 days to run "chemical tests." Independent outlet *Mediazona* later published footage from a webcam purporting to show a police convoy heading away from the prison sometime around midnight the night before Navalny's mother visited the area. Many commentators concluded the body had been moved in advance of her visit. Separately, *Novaya Gazeta Europe* reported, based on anonymous sources, that Navalny's chest had unusual bruising, as though he had been held down prior to receiving chest compressions, while *Verstka* reported that there had been unusual lockdowns and searches at the prison the day before the death.

3. (SBU) Though Russian law requires releasing the body to the next of kin, a number of commentators said the government could seize on Navalny's "extremist" and "terrorist" designations to avoid handing it over. Even if there were no foul play, most commentators assumed the authorities would want time to think through how a public funeral and burial might affect protest mood in advance of the March 15-17 presidential election. As Berlin-based Carnegie expert Tatiana Stanovaya wrote online, given President Putin's fear of external interference, the regime likely views any unrest resulting from Navalny's death as an attempt by Navalny's supporters to damage the triumph of his re-election.

(SBU) In Moscow, Liberal Society in Muted Grief

4.-(SBU) While there was a flood of grief online, Moscow's streets were relatively quiet, especially compared to protests at the beginning of the war or in previous Navalny-led actions. On Friday night, several hundred people gathered in what appeared to be an orderly and mostly quiet line to lay flowers at the Solovetsky Stone, a memorial to prisoners of the Gulag on Lubyanka Square, in front of FSB headquarters. Police presence was heavy. Mourners also brought flowers to the Wall of Shame, a memorial to political repression, as well as the memorial to Boris Nemtsov on a bridge adjacent to Red Square. Media reported that the hundreds of flowers, piled high at each location, were removed by plain-clothes security officers overnight. By Saturday morning, Lubyanka Square was quiet and mostly clear of people, except for a few cameramen and a number of conspicuous security types taking pictures of anyone who approached the memorial. By midday, the number of visitors picked up again, as did the number of police. The

Australian, Canadian, Danish, and UK ambassadors laid flowers at the site. OVD-Info, which tracks protest-related arrests across Russia, reported 396 people detained over the weekend in 39 cities. Media reports suggested police primarily detained those who unfurled banners or shouted slogans, while mostly leaving quiet mourners alone. Ambassador Tracy laid flowers at the site Sunday morning, the square mostly quiet and empty. (b)(6) reported the same later that afternoon, and speculated that the arrests from days prior might have dampened turnout.

-(SBU) Opposition's Next Steps Unclear

5. (SBU) Yuliya Navalnaya – Alexey's wife – briefly addressed the Munich Security Conference on Friday, soon after news broke of her husband's death. Visibly shaken, she said she held Putin personally responsible for Alexey's death – as well as "what they've done to the country" – and called for the defeat of "this horrific regime." Over the weekend, she released a video reminiscent of Alexey's, asserting that she knew who was responsible for the death and would reveal the details of an investigation soon. Separately, independent outlet *Kholod* published a list of names and pictures of all Russian officials who had been involved in Navalny's various investigations and court proceedings under the headline "Evil has a name." But given the preexisting organizational tensions within Navalny's

Anti-Corruption Foundation and the opposition movement more generally (B-C), it remained as unclear as ever how Russia's regime opponents and anti-war protestors might proceed in Navalny's absence.

(SBU) Supporters: The Candle as the Last Available Protest

6. (SBU) Liberal commentators and Navalny supporters were uniform in their grief and generally saw Navalny's death as marking the end of hope for the opposition movement within the country. Carnegie expert Andrei Kolesnikov called the candles, carried by individuals to the memorial, "the last weapon of a civilized person and citizen," and labeled the authorities the "not the heirs of the Great Victory of 1945, [but] of the Great Terror of 1938." Yuri Dud, one of Russia's most popular YouTube journalists, who interviewed Navalny while he recovered in Germany from Novichok poisoning, wrote that, "Putin's Russia is built on fear" but Navalny had provided an example of "fearlessness," his "superpower" after deciding to return to the country in January 2021. Dud hoped that the "signal" of fearlessness would permeate society even after death. 1. (C) Summary and comment: In public comments following the March 22 terrorist attack on Crocus City Hall, President Putin has all but accused the United States of orchestrating the attack, while insinuating Ukraine and its supporters likely played some role. Senior Russian officials have subsequently made the link explicit, blaming the United States and Ukraine. It was a textbook Kremlin information operation – Putin outlined the contours of the conspiracy, senior officials solidified the claims, and Kremlin propagandists illuminated the disinformation with provocative details. Since launching its war against Ukraine, the Kremlin has consistently labeled internal unrest or security incidents as "terrorism" and tied them to Western actors, including Ukraine. At the same time, Putin has, for over two decades, spoken publicly about his belief that the United States sponsored international terrorism, "created" ISIS and Al-Qaeda, and stoked Chechen separatism. Meanwhile, adding to the Kremlin's mental and linguistic contortions of reality, Russian authorities have designated "the international LGBT movement" and Aleksey Navalny's anti-corruption efforts as "terrorists," and Meta/Facebook as "extremist," while regularly hosting delegations from Hamas and the Taliban. The fog of the conspiracy provides the Kremlin justification to do as it sees fit, at home and abroad. For many years, Stalin sent thousands to the Gulag for the barest perception of "Zinoviev-Trotskyite-deviationist" sympathies – which he, himself, defined. Putin has found new conspiratorial nonsense to prosecute the war and repressions at home. End summary and comment.

3. (SBU) Putin, 17 hours after the March 22 ISIS attack on Crocus City Hall and portrayed by state television as diligently issuing orders and considering the facts of the situation, asserted the terrorists were endeavoring to flee to Ukraine, where a "window" had been opened for them. Without explicitly pointing to the United States, he pledged to find and punish those who "stood behind the terrorists." He then compared the attack to a "show execution" and a Nazi massacre. Given his mention of Ukraine and his repeated comparisons of Ukraine and its partners to the Nazis, the implication was clear: though Islamic terrorists undertook the attack, it was sponsored by Ukraine and the West.

4. (SBU) Putin all but explicitly blamed the United States in his March 26 remarks to government officials. While acknowledging that "radical Islamists" committed the attack, he insisted Russia would uncover the "customer" (zakazchik). "Who benefits from this?" he asked, rhetorically - a question that has widespread resonance with a conspiracy-minded public. "This atrocity may be only a link in a whole series of attempts by those who have been fighting our country since 2014 at the hands of the neo-Nazi Kyiv regime," he said, answering his own question. Suggesting there was a "customer" – as opposed to ISIS planning and executing the attack – is easily understood by many Russians, conditioned by countless uninvestigated murders to assume ultimate responsibility lies with some shadowy outside force.

-(SBU) Senior Russian Officials Repeat - and Make Explicit - the Conspiratorial Message


5. (SBU) Several senior Russian officials subsequently took Putin's conspiratorial message a step further by explicitly accusing the United States of orchestrating the attack. In response to a March 26 press question about whether the United States, Great Britain, and Ukraine were behind the attack, FSB Director Bortnikov said, "We think so." He added that Ukraine had intended to "greet them [the attackers] as heroes" on the other side of the border. At the same event, when asked if the attack was committed by ISIS or Ukraine, Security Council Secretary Patrushev responded, "Ukraine, of course." Duma Speaker Volodin said March 27 that the "terrorists and those who stand behind them, the bloody regime of Ukraine, Washington, [and] Brussels" hoped the attacks would "split our society [and] sow discord." MFA spokesperson Zakharova said March 27 that the U.S.

"commitment and involvement in this story is obvious," because, counterintuitively, the United States had so promptly denied Ukrainian involvement. Also on March 27, Russia's Investigative Committee announced it had initiated an investigation into "the organization, financing and conduct of terrorist acts by the United States and other Western countries directed against Russia," at the request of three Duma representatives and right-wing ideologue Alexander Dugin.

(SBU) Kremlin Conflates All Threats as "Terrorism"

6. (SBU) In the context of Russia's war against Ukraine, Putin and senior officials have consistently conflated civil unrest and threats to Russian territory as "terrorism," and actions to suppress any internal threats to the regime or the "constitutional order" as "counterterrorism." In his March 25 remarks, after outlining Ukrainian war objectives - e.g. "the attempts to enter and gain a foothold in our border territories," "shelling...[of] energy infrastructure," and "attempted missile attacks on the Crimean Bridge" - Putin said the March 22 ISIS attack "logically fit into this series." When asked in the March 26 press appearance whether a terrorist threat still existed in Russia, Bortnikov likewise conflated the two issues, seamlessly responding, "Yes, you see what is happening in Belgorod, Kursk, and Bryansk...we have to do everything to stop events like that which happened at Crocus City Hall." In a March 26 event also attended by Putin, Prosecutor General Krasnov said the "performers, customers, and curators [of the March 22 attack] will inevitably be punished," and - in the very next sentence -"That is why the most important task for Russia remains achieving the goals of the special military operation." In other words, all threats to Russia - whether from ISIS or justified war aims - constitute "terrorism."

7. (SBU) While this likely represents cynical and deliberate obfuscation, it also represents new institutional priorities. According to an investigation by Novaya Gazeta Europe, the vast majority of "terrorist" activities prevented by the FSB in recent years have been attributed to Ukrainian special services. At the same time, the number attributed to Islamist groups fell markedly in 2022.



8. (SBU) At the same time, Putin has long blamed the United States for "creating" Al-Qaeda and ISIS and – in an example he has cited repeatedly for two decades – for allegedly supporting Chechen separatist groups. In his February interview with Tucker Carlson, Putin asserted that the United States had provided "political support, information support, financial support, even military support...to terrorist groups in the Caucasus." In his June 2023 plenary address to the St. Petersburg International Economic Forum, Putin asserted, "When al-Qaeda began to fight against us in the Caucasus, everyone forgot [they were an enemy, because] if something can be used in the fight against Russia, it is used to the fullest." In a 2017 Oliver Stone documentary, Putin said, "When we started having problems in Chechnya and the North Caucasus, unfortunately, the Americans supported these processes." "The Americans themselves raised both al-Qaeda and bin Laden," he added, "but it all got out of control." He made similar claims in interviews in 2004 and 2015.



Separately, the Russian Mission to the UN called a UNSC meeting on Ukraine on March 22. Russia also plans to host an Arria formula meeting in March on Western arms transfers to Ukraine.

-(SBU) RUS/IO ALDAC Forthcoming on Engagement Policy for Russian Officials: The ALDAC will refresh bilateral and multilateral engagement policy with Russian officials and guidance for countering Russia's influence in multilateral bodies.

(SBU)-S Town Hall March 4 with Embassy Moscow: S pledged full support for Post and praised Post's accomplishments, amid enormous constraints.
